Notification No. 694/C, dated 20-3-1962-In exercise of the powers conferred by Section 10 of the Orissa Home Guards Act, 1961 (Orissa Act 22 of 1961), the State Government to hereby make the following rules namely :

2.	Definitions-In these rules unless the context otherwise
requires -

(ii)	"Commandant-General", "Deputy Commandant-General" and "Commandant" respectively mean Commandant-General, Deputy Commandant-General and Commandand of Home

3. Appointment of members of Home Guards-No person shall be appointed as a member of the Home Guards-	
(a)	unless he has attained the age of twenty and has not com- pleted the age of sixty years ;
(b)	unless he has passed at least the lower primary examination in any language ; and
( <b>c</b> )	unless he has been medically examined and is in the opinion of the Commandant physically fit :

Provided that the Commandant-General or the Deputy Commandant-General, if so authorised by the Commandant-General, may in suitable cases relax the conditions prescribed in Clauses (a) and (b).

4. Application for appointment—A person desiring to be appointed as a member of the Home Guards shall make an application in Form 'A'.

5. Home Guards Advisory Committee-(1) The State Government may, after constitution of the Home Guards, appoint a Committee to be called the Home Guards Advisory Committee for the

(2) The Home Guards Advisory Committee shall consist of such members, as may be nominated by the State Government.

It shall be the duty of the Home Guards Advisory Committee (3) to review the working of the organisation from time to and to advise the Commandant-General regarding the improvement in its working.

Pledge-Every person before his appointment as a member 6. of the Home Guards shall sign a pledge in Form 'B' before the Commandant or an officer authorised by him for the purpose.

7. Certificate-Every person appointed as a member of the Home Guards shall receive a certificate of appointment in Form 'C'

8. Term of office-The term of office of a member of the Home Guards shail be three years :

Provided that if any such member is found to be medically unfit to continue as a member of Home Guards his appointment may be terminated before the expiry of the aforesaid term of office :

Provided further that a person appointed as a member of the Home Guards shall be eligible for re-appointment.

Limit of age for a member of the Home Guards-No 9. member of the Home Guards shall continue to be such member after completion of the age of 60 years :

Provided that the Commandant-General or the Commandant may relax the age-limit in suitable cases.

10. Conditions subject to which power of discharge may be exercised-No member of the Home Guards shall be discharged under Sub-section (2) of Section 8 without being given one month's

11. Resignation—A member of the Home Guards may resign his office by an application in writing addressed to the Commandant:

Provided that such resignation shall not take effect unless the Commandant accepts the same after being satisfied that there are good and sufficient reasons for the same.

12. Organisation—The organisation shall comprise of the Commandant-General, the Deputy Commandant-General and such officers as the Commandant-General may appoint on his staff. The Home Guards constituted for each district shall consist of a Commandant, a Second-in-Command, Senior Divisional Commanders, Divisional Commanders, Company Commanders, Senior Platoon Commanders, Platoon Commanders, Sergeant-Majors, Quarter Master Sergeants, Platoon Sergeants, Section Leaders, Assistant Section Leaders and Sections consisting of twelve Home Guards. Three sections shall form a latoon, three platoons a company and at least three companies a division. A unit may have more than one Division. The Home Guards aforesaid shall also consist of such staff officers as the Commandant may, with the approval of the State Government, determine.

13. Powers of the Commandant – 1) The Commandant shall exercise general supervision and control over the working of all the units and co-ordinate the work of the Home Guards within the district under his jurisdiction and shall be directly responsible to the Commandant-General for the efficient working, discipline, administration and training of the member of Home Guards.

(2) Subject to the supervision and control of the commandant any officer of the Home Guards authorised by the commandant in this behalf may exercise the powers conferred on the Commandant in such circumstances as the Commandant may specify.

14. Discipline-(1) A member of the Home Guards shall obey every order of his superior officer.

(2) For the purpose of administration and discipline a member of the Home Guards shall subject to the overall control of the <u>Comman-</u> dant-General, be under the control of the officer immediately superior to him :

Provided that if a contingent of Home Guards is acting in conjunction with the Police Force the senior officer of such contingent present shall be under the immediate control and subject to the directions of the senior officer of such Police Force who is not below the rank of an inspector.

15. Uniform, accoutrements, etc.—A member of the Home Guards shall, while on duty wear the uniform supplied to him and may also carry such weapon as may be specified by the Commandant-General. 16. Training—The members of the Home Guards shall undergo such course of training and at such places as may be determined by the Commandant-General from time to time.

17. Functions and duties—<sup>1</sup>[(1) The Home Guards shall discharge the following functions and duties namely :

- to help the police in maintaining law and order and internal security during any emergency when called out for service in aid of the police;
- (ii) to render assistance during narural and other calamities, such as, earthquake, floods, famine and fire for protection of persons and their property;
- (iii) to operate transport, communications, electricity, water and other essential services when the normal services are not functioning;
- (iv) to collect and communicate any, information relating to the breach of public peace to the local police;
- (v) to prevent the commission of offences and public nuisances;
- (vi) to obtain and communicate the officer-in-charge of the police-station, correct information about criminals, criminal classes, vagrants and wandering gangs, persons residing in or passing through the police-station;
- (vii) to assist the police in quelling communal disturbances, and industrial and internal disorders;
- (viii) to assist the police in maintaining law and order in fairs, festivals and big gatherings;
  - (ix) to assist the civil defence organisation during the national emergency;
    - (x) to guard vulnerable points/areas, lines of communication bridges, embankments, etc., as and when necessary;
    - (xi) to watch and report forthwith to the local police the names of the persons who may be found engaged or taking part in activities which are anti-social in nature or prejudicial or subversive to the interest of the Union; and
  - (xii) such other functions and duties as may be assigned to them from time to time by the State Government in consultation with the Commandant-General.]

(2) A member of the Home Guards constituted for any area shall be liable to serve in any other area in which the Act is in force.

18. Calling up of Home Guards—While calling upon the District Commandant under Sub-section (2, of Section 4 the District Magistrate or the Superintendent of Police, as the case may be, shall give the Commandant order in writing for calling out the members of the Home Guards, stating therein the particulars of the unit or detachment of any unit of the Home Guards that has to be called out and the place or places where they should mobilise. The duties which the Home Guards shall have to perform shall be explained to the members of the unit or detachment of the unit by the District Magistrate or the Superintendent of Police either personally or through the officers of such unit or detachment, as the case may be.

19. Remuneration—Officers and other members of the Home Guards shall be entitled to receive such allowances and at such rates as the State Government may, from time to time, determine.

20. Compensation—If a member of the Home Guards suffers any damage to his person or property while under training or on duty, he shall be paid such compensation as may be determined by the State Government; provided that such damage is not caused by his own negligence or wilful act or omission in contravention of any of the provisions of the Act or rules made thereunder or orders or directions issued by his superior officer.

21. Motorised unit—A motorised unit of the Home Guards may be formed with members owning motor vehicles who desire to place their vehicles at the disposal of the Commandant, when called out under Section 4 of the Act. Only those members owning motor vehicles who hold a driving licence and whose motor vehicles are certified to be in fit condition or for use by the Motor Vehicles Inspector of the area shall be enrolled in this unit. The State Government shall bear the costs of petrol, incidental expenses and necessary repairs for the use of such motor vehicles by the Home Guards. The State Government shall also bear the difference between the riot and ordinary insurance in respect of such vehicles in cases in which such members have taken out riot insurance policies in respect of such vehicles.

- in any emergency I shall be liable to be called out on duty at any time and for any period and in any part of the State of Orissa;
- (2) 1 shall be liable to undergo training and attend parades in accordance with the orders of my superior officers;

(3) I shall be required to take the following pledge, namely :

"I......residing at......do solemnly and sincerely declare and affirm that I will well and truly serve the Government of Orissa as member of the Home Guards without favour or affection, malice or ill-will or communal or political bias; and that I will, to the best of my powers, discharge the functions and duties assigned to me for metting any emergency, and for serving the people in any calamity and for the protection of persons, the security of property and the public safety and that I will, to the best of my skill and knowledge, discharge all the duties as such member, faithfully according to law,"

(4) I shall be required to serve for a period of three years in the Home Guards unless I am allowed to resign in pursuance of the Orissa Home Guards Rules, 1962.

Note—(1) If you are a Government servant or an employee in a local authority, a firm or any other office, you should send this form through your superior officer with his certificate that he has no objection to your attending the training and that he will release you for duty in an emergencey at any time and for any period and in any part in the State of Orissa.

(2) After completing the form you should post it or deliver it to the Commandant, Home Guards of the District. You will receive intimation in due course whether your services can be utilised.

(3) In requesting the employer or the superior officer to issue certificate mentioned in (1) above it may be pointed out that emergencies such as those that are referred to in paragraph (1) are not likely to arise very often. Prospective Home Guards should therefore not be scared away nor should their employers, or superior officers, hesitate to issue the above certificate for just this reason.

# The Orissa Home Guards (Appeal) Rules, 1963

Notification No. 1888-CD-74/63, dated 28-3-1963—In exercise of the powers conferred by S-ib-section (2) of Section 13 of the Orissa Home Guards Act, 1961 (Orissa Act. 22 of 1961), the State Government 'do hereby make the following rules :

1. Short title—These rules may be called the Orissa Home Guards (Appeal) Rules, 1963.

2. A member of Home Guards may appeal against an order of suspension, reduction in rank, discharge or dismissal of imposition of any fines.

3. (a) Any member of Home Guards aggrieved by-

- (i) an order of Commandant may appeal to the Deputy Commandant-General;
- (ii) an original order passed by the Deputy Commandant-General may appeal to the Commandant-General ;
- (iii) an original order passed by the Commandant-General may appeal to the State Government.

(b) An original order passed with the concurrence of any superior outhority shall be deemed to be an original order of the superior authority.

4. (a) Every appeal petition shall be presented to the officer, against whose order the appeal is preferred, without court-fee stamp. The officer shall forward the appeal to the appellate authority without undue delay with his comments on each point raised in the appeal petition in separate sheets alongwith the proceedings of the enquiry his original order, other connected papers and the service records of the appellant.

(b) The order of the appellate authority in such appeal shall be final.
